



# TOMAHAWK SCOUT RESERVATION 2010 FAMILY ISLAND RESERVATION FORM

All cabin reservations and payments are handled at our St Paul office.  
Check-in and check-out will be handled at Tomahawk Scout Reservation.

- A \$50.00 refundable deposit is required for all keys & cleaning deposit upon arrival.

The primary purposes of family camp at Tomahawk Scout Reservation is to provide the families of unit leaders staying at camp the opportunity to spend time together, as well as, offer other Scouting families, an opportunity to enjoy and become familiar with camping facilities that are available to their children in the Scouting program.

**Rental Fees:**

- \$295 per week for families who have at least one adult registered and participating with a troop in camp during the same week.
- \$350 per week for families who have a youth or family member registered with the BSA
- \$20 per night for a trailer site / \$12 per night for a tent site

The Northern Star Council Camping Committee has developed a policy that provides the families of unit leaders who are in camp the first opportunity to make a reservation at family camp. People who have one or more members of their family registered with the Northern Star Council are given next priority to make reservations at family camp.

1. January 1, 2009 through August 31, 2009: Families with a Scout or adult registered to attend Tomahawk in 2010 can register for up to 3 cabins and 3 tent/trailer sites in Family Island.
2. September 1, 2009 through December 31, 2009: Families with a youth or adult registered with the BSA but not attending Tomahawk in 2010 may make a reservation.
3. January 1, 2010: Reservations open on a first come first served basis.
